To whom it may concern,

The Korean Ministry of Food and Drug Safety (MFDS) would like to appreciate your efforts to ensure safety of exported foods and MFDS will stay committed to promote bilateral cooperation in food safety.

MFDS has conducted our document review in place of a 2020 on-site inspection and asked for submitting the requested documents by July 31st which had been extended.

We are fully aware of difficulties in performing inspection such as travel restrictions, working from home triggered by the continuous spread of the COVID-19.

Given this adversity occurring at an international level, MFDS accepted a request for a due date extension made by several countries.

As making a decision to push back the due date again to **September 15th 2020** under mutual understanding, we kindly ask competent authorities, foreign food facilities and establishments to meet the date. Please note that if facilities or establishments fail to meet the deadline or to complete submission, they will face restrictions in international trade such as intensified inspections at customs.

*(Food products) The result of either self-inspections conducted by foreign food facilities or inspections conducted by the competent authority of an exporting country will be accepted.

*(livestock and fishery products) The result of inspections conducted by the


competent authority of an exporting country according to the bilateral Sanitation Agreement will be accepted.
